This application will be kept confidential and on file at the BiG Heroes office. Applications are used by the HERO's Executive Board Committee to identify and evaluate potential board candidates. This committee will interview potential board members and make recommendations to the full board of directors. Members are elected by a majority vote of current board members.

Member of the Board Job Description

- 1. Serves a minimum of 1 two-year term on the Board. Eligible to serve 2 two-year terms.
- 2. Accountable to the BiG Heroes Board of Directors.
- 3. Attends all board meetings in person and other important related meetings (i.e., fundraising). The Full Board of Directors meets the 2nd Thursday of every month at BiG Heroes, Inc. (or limited emergency basis as the need arises). Meetings last 1 -1 ½ hours.
- 4. Makes a serious commitment to participate actively in BiG Heroes committee work.
- 5. Volunteers for and willingly accepts assignments and completes them thoroughly and on time.
- 6. Stays informed about committee matters, prepares themselves well for meetings, and reviews and comments on minutes and reports.
- 7. Builds a collegial working relationship with other committee members that contributes to consensus.
- 8. Participates in the committee's annual evaluation and planning efforts.
- 9. Participates in membership recruitment for the organization.
- 10. Participates in fund raising for the organization. A minimum \$500 commitment fundraiser is required.
- 11. Understands that Big Heroes is in the infancy stage of building its organization and more time and effort is required of Board Members.
